MADHYA PRADESH for starting the new D.El.Ed. Course of 2 (Two) Year duration with an annual intake of 50 (Fifty seats) from the academic session 2014-2015.

The institution shall ensure that the required number of academic staff for conducting the course is always in position.

The institution shall adhere to the mandatory disclosure in the prescribed format and display upto-date information on its official website.
